Subject: HIV Planning Group New Member Application

Dear Colleague:

Enclosed is an application package for membership of Pennsylvania's statewide HIV Planning Group (HPG). New members are being recruited to fill representational gaps. *All* applications will be considered, and applicants from all walks of life are appreciated. To fill gaps in the composition of our membership we are seeking: 1.) applicants who are persons living with HIV; 2.) individuals who identify with or represent communities listed on the enclosed application form and are also a racial and ethnic minorities, especially African-American/black; between the ages of 14 and 29; and/or transgender; 3.) representatives from Ryan White Part B grantees; 4) representatives or clients of HIV prevention/testing/PrEP providers; and 5) County/Municipal Health Departments. Within these membership categories, we are also seeking to increase regional representation from all geographic areas of the state, especially the southcentral and all southwestern regions.

Along with this invitation letter, the HPG application packet contains the application form and the HPG Applicant Quick Guide. It is important that applicants receive the entire package in order to understand the HPG process. Applicants should be sure to completely answer all questions on the application. Please feel free to reproduce and disseminate copies of this package to all individuals, stakeholders, and organizations interested in HIV planning who may wish to be considered for membership. Self-nominations are also encouraged.

APPLICATIONS ARE DUE to the Division of HIV Disease's Planning Contractor, the University of Pittsburgh's HIV Prevention and Care Project, by **Friday, November 24, 2023**.


Please notify the lead facilitator of the Recruitment Working Group, Corrine Bozich by email if the application is needed in another format (such as Braille) or language (Spanish versions are currently available on StopHIV.com).

An HPG workgroup will review all anonymized applications and make recommendations for new members. It is expected that the selection process will be completed by late December 2023. A hybrid virtual/in-person orientation for new HPG members will be conducted during the first 2024 meeting. Each new member will receive orientation materials and be assigned an experienced HPG member as a mentor.

Two-day meetings will be held every other month, beginning in January 2024. Typically, four meetings are in Harrisburg, and the other two are paired with townhall events that rotate throughout the commonwealth. Meetings are currently being held in a hybrid fashion, with options to participate either virtually or in person. Our Harrisburg HPG meetings typically run from approx. 9a.m.–5 p.m. on the first day, and 9 a.m.–3 p.m. on the second day.

The continuum of HIV services is at the core of integrating care and prevention in Pennsylvania. An essential component of these services is broad stakeholder engagement and feedback for comprehensive, integrated HIV planning, monitoring the HIV Integrated Prevention and Care Plan, priority setting, and needs assessment. All members are expected to attend and actively participate in all meetings unless circumstances beyond their control prevent this from happening. Please take advantage of this important opportunity to positively impact the direction of HIV planning in Pennsylvania. Thank you.
