Division of HIV Disease DOH:	
 Mari Jane Salem-Noll (Prevention Section): We submitted the Integrated Surveillance and HIV prevention Grant as of yesterday. Most of our focus has been on this grant for the past three months. We're doing monitoring of our health departments this fall, starting in October. We're wrapping up monitoring reports of our 19 test providers. We did site visits late spring/early summer. My old positionwe wrapped up the interviews. We will probably be making a recommendation towards the end of the week to fill that position. Hopefully by the next time we meet, you will get to meet the new, what I'm calling, the "Grants Management Program Administrator" for Prevention. Monisola Malomo (Epi DOH): We are awaiting news from two providers to support the data to care initiative 	
 Julia Montgomery (Care Section): Had a HRSA "Reverse Site" visit two weeks ago- everything you ever wanted to know about Part B. It was like "drinking from a firehose in legislation and requirements around the Ryan White program. We had 6 staff attend who are relatively new to the HRSA oversight Suzanne and I went to the U.S. conference on AIDS. Nancy Pelosi was one of the keynote speakers during the conference. She is a huge advocate of Ryan White, HIV Programming, HIV Services, and it was very refreshing to hear that she is very dedicated to ensuring that funding is maintained for the services we provide. Staff are beginning to schedule and half schedule monitoring visits to the regional sub recipients. We've almost completed "Subsequent Available Funds" documents for all of the regions to put out more Ryan White dollars and more Ryan White eligible services. Whitney is our new Program Officer for several of the Ryan White Care 	

- We are working to implement a data to care initiative within the Division of HIV Disease you utilize the data for people living with HIV to link them into care and to reach out to find them and reengage them in care. We are hiring a coordinator to do this and will be working with Bureau of EPI. We will be working to develop policies and protocols.
- Leonard Janson is no longer working with us your data concerns can be sent to me in the meantime.

Janine Streck:

• Program service standards have been completed and sent out and you also have a copy – if you have questions or comments you can email me. This is part of our requirement of HRSA to make sure our funds are distributed in a standard manner.

Cheryl Henne (SPBP Program Manager):

- Medicare Part C and D Enrollment phase- letters have been sent out
- Assurance Premium Assistance Initiative- slated to begin providing coverage in January 2018. More info coming as we get closer
- The online application process has been tied to the premium assistance and is being worked on.
- We are working on putting together a policy and procedure book we are creating a document that will be helpful in one composite documents and flow to that.
- We are developing monitoring tools for MAI in response to HRSA visit, monitoring the PA Department of Aging, and also Magellan Health Services.
- Some enhancements to the customer service line are being made-Gets customer service rep to customer's file faster to expedite the process.
- Activities we had some folks from SPBP attend the reverse site visit.

 We are also hoping to do a proclamation from the Governor – working on that now. Continuing to build on what we did last year If anybody in the area could attend the events or spread the word about these events once the information comes out, that would be great! 	
 Jill Garland (Director, Division of HIV Disease): If you're a Ryan White Part B provider As of the 2017 federal fiscal year, we are required to have written service standards that we ensure all services provided by Ryan White Part B funds are provided in a standard manner Currently the Program Services Standards is entering its final draft We are asking for feedback before implementation These will be part of the requirements of the new grant with the regions and providers that go into effect July 1st, 2018 (start of new grant year) The latest federal budget proposal does fund CDC and HRSA at level funding. HOPWA - we will see a small increase in funding from them. We have permission to post this integrated plan on our website – it was approved to be posted and will have it posted as early as next week. There will also a link to it from StopHIV. We are working on spending plans – we prepared our state fiscal 2018-2019 to really look at our plans and make changes where necessary in light of our new structure. "New Structure" 	
 Through the SPBP we collect a significant amount of rebates through drug purchases Over the years, the accounting/payment structure didn't allow us to use rebate dollars prior to using Ryan White dollars "New structure"- made some changes moving forward that will allows us to use the Ryan White dollars prior to drawing down any grant dollars Because we get a large number of rebate dollars we are determining how to use those. This will help us get the dollars out in advance so we are not spending funding at the last minute That means we will be able to put additional funds into providing services and resources to clients. We are pleased to have this mechanism in place for RW eligible services. 	
• We've been in discussion with NASTAD lately over trying to redefine what eligible Ryan White services are	

- Traditionally: services for individuals who are HIV positive, eligible, and in the Ryan White Program
- Trying to explore other opportunities, like early intervention and disease intervention work

- We are doing analysis of consumer survey to have report written by end of next month.
