The grant application is submitted once every five years and will have to be submitted in 2021. <p>Division of HIV Disease: Care Section</p> <ul style="list-style-type: none"> For questions on Care, please contact Cheryl Henne at chenne@pa.gov Semi-annual Progress report for COVID funds was submitted 11/1 to HRSA. AACO is the only region required to provide information for this report as all other regions received rebates in lieu of CARES COVID funds. The Non-Competitive Continuation (NCC) Application is due to HRSA 11/20. This is the required submission to apply for next year's grant funding. A full application is now completed every 5 years, with subsequent annual submissions of the NCC for funding. At the Ryan White Conference earlier this summer, HRSA announced the new framework for Unmet Needs. This information has been a reporting requirement for grant applications for some time, however HRSA has most recently revised/clarified the framework, and the analysis requirements with the expectation for this to be included in the next full grant application which is due for 2022. This is a change for both Part A and B grantees. More information on this to follow. 	<p>All attendees were asked to provide any announcements advance. All attendees received an email with the announcements prior to the meeting.</p>

- Funding will be made available through the 5 year spend plan project for Localized Media, Emergency Preparedness and Innovation. The planning forms have been drafted and are currently under review. Following approval, plan forms will be sent to Regions to provide the division with ideas as to how they wish to spend these available funds.
- Staffing changes: Nenet Hickey has joined the Care Program team. She has been assisting with the CAREWare transition activities and we are pleased to announce that she is dedicated to becoming our resident CAREWare expert. She is currently working on user guides for the various functionalities in CAREWare working with information from AACO, JPROG, other states, and Natasha in the NC region. The CAREWare expertise being developed, and the continued dedication to this activity will provide the ability for on-going TA support and trainings/materials from the department. Nenet will also be working with the team for data clean-up and consistency in reporting. Nenet is excited to be part of the team, and we are excited for the development of this vital resource.
- For the 2020 RSR Reporting, Joanne will be assisting the Division with the 2020 Calendar Year (1-1-2020 to 12-31-2020) - RSR reporting to HRSA.
- The (Grantee), PA DOH is required to include in the Electronic Handbook (EHB) all Regional Grantees and Provider offices who were contracted to provide Ryan White Care Services paid for with Ryan White funding and/or Rebate funding during the 2020 Calendar year.
- Joanne Valentino will be sending out separate e-mails in Mid-November to each regional office containing an excel spreadsheet to review, add, and / or change and / or delete Region and Provider Contract information and Funding amounts and services by funding stream.
- No Client data upload to the EHB website is required for the Care Services paid for with Rebate funding. However, just like we did for the 2019 RSR reports last year, each Provider office who only receives rebate funding will need to access the EHB to revise and or input information about their office. (Known as the RSR Provider report). Instructions will be e-mailed in early January 2021

- Clinical Quality Management Plan
 - Regions provided collaboration in reviewing and providing feedback.

- In the process of reconciling the draft with updates/revisions, the next step is to submit for final Executive Approval.
- Program Service Standards
 - At the Division's request, Dr. Givens and an HPCP team provided SPBP and HPG with the revised Program Service Standards, to include the new addition of Universal Standards for review/comment.
 - This information was distributed, with a link for comments.
- Taxonomy
 - To be finalized and distributed, tentatively by 11/30/2020
 - Tentative plan to schedule a call with Regional Grantees to provide an overview.
- Data Integrity Pilot Program
 - Began discussions with Regions to determine how contracts are entered into CW, and the naming conventions for Sub-Service categories.
- CAREWare conversion, began 10/22/2020 with NCDAC. Wyoming Valley will be next to go through the conversion, followed by Caring Communities.

Division of HIV Disease: Monitoring and Evaluation

- The policy for site monitoring in the time of COVID and subsequent travel restriction will be forthcoming.
- Allison Prim is now the Project Officer for United Way Wyoming Valley and assumed the for FHCCP.
- We are asking all regions to ensure all their providers send their CAREWare Data submissions to Stephen Wimmer on a monthly basis. CAREWare submissions are due to DOH by the 15th of the month.
- We are in the process of hiring a new Public Health Administrator Associate (PHPA2) to work with the Prevention side of the Monitoring and Evaluation section. A candidate is expected to be selected in the very near future.
- Virtual monitoring visits with the County and Municipal Health Departments have been scheduled and will start the week of November 16th.
- Participating Provide Agreement Performance (PPA) Measure Reports are being sent out this week. Providers will be able to review their performance for the year and compare data on select indicators from the previous year. We will be actively monitoring the performance of the providers and identifying opportunities for improvement where indicated.

 - Identifying Alternative Permanent Housing is part of the HUD HOPWA Modernization and additional feedback will be provided when the Quarterly Monitoring Reports are submitted.
- Required Yearly HOPWA trainings completed last week
 - Regions and providers who were able to complete the trainings by Friday (Oct. 23rd)
 - Offices receiving funding must complete the training once every 3 years.
- CAREWare and the HOPWA Program
 - Individual emails will be sent out to the regions who provide direct services including any provider offices to confirm there are 2 separate contracts in the CAREWare program.
 - One for regular HOPWA funding and One for HOPWA CARES Act COVID-19 Funding.
- The HOPWA Program Plan from the Regional Grantees for the 2021 HUD HOPWA funding is due December 15, 2020.
- 2020 HOPWA CAPER Reporting Regions should be working on the text portion of it now---- due Monday, January 25, 2021. This will be for the HUD HOPWA Formula funding only.
- The CAPER Report for the COVID funding will be due in late spring / early summer of 2021.

- Updates on the SPBP website
 - Drug Formulary – formulary updated 10/1/20
 - Covered lab tests for uninsured individuals – updated 9/1/20
 - Preliminary 2021 Medicare Part C and D plan list was updated 11/2/20 (list will be updated as we receive signed agreements back from the Medicare plans)
 - Added SPBP@pa.gov email to website after the customer service phone number for anyone that needs assistance

- Online enrollment system (MRx Enroll)
 - Case manager portal
 - Updated the system to allow Agency Admins and backup Admins to add/update/change case managers associated with their facilities
 - New facilities will need to register their admins/backup admins with us the first time through the same process we used for adding facilities/admins/case managers
 - After facilities/admins are enrolled, they will be responsible for adding and updating case manager info for their facilities directly through MRx Enroll
 - New agency/facility requests can be sent to SPBP@pa.gov. We will send the agency/admin enrollment info to be completed and returned
- Medicaid back-billing
 - Manual void/rebill process with pharmacies using HMS
 - Medicaid ID was added to our daily file match with Medicaid – completed August 2020
 - Internal contract changes were completed in September and the void/rebill process is being built to support the Medicaid recovery process via the void/rebill process with pharmacies – claims will be identified and the pharmacies will be notified that the claims will be voided and are to be re-billed to Medicaid for payment and out of pocket costs submitted back to SPBP for payment
- SPBP temporary policy exceptions/changes due to the coronavirus pandemic
 - The current plan is to turn the early refill limits back on effective 1/1/21
 - Continue with:
 - Accepting paper applications with signatures from providers or case managers on behalf of client
 - Not counting COVID stimulus checks or additional unemployment compensation of \$600 per week against the member's income limits

- The CDC Annual Report which is the request for the next year's funding was submitted in September. We are now waiting for the Technical Review.

- A Public Health Program Assistant Administrator (PHPAA) has been posted. This position will focus on cluster investigations and partner services and will report to the Testing and Partner Services Administrator, Jon Steiner.
- D2C services resumed November 16, 2020.
